PUBLIC AUCTION NOTICE

**Terms and Conditions for auction shall be as under:-**

1. The successful bidder has to take up the material "on as is where is basis".
2. Each bidder shall have to deposit Rs. 2000/- (Rs. Two Thousand Only) along with ID Proof (Ration Card/Voter Identity Card/ Aadhar Card) with cashier of the office before taking part in the auction. The amount of security shall be refunded to the unsuccessful bidders.
3. The amount of security shall be adjusted toward the final payment of bid money in respect of successful bidder. The successful bidder, whose offer will be accepted, shall be required to deposit 25% of the bid money immediately on the fall of hammer, failing which the undersigned will have the right to forfeit the security money.
4. The bidder shall have to remit the balance amount within seven days from the date of the auction. The sale release order shall be issued after receiving the balance 75% (including security deposit) of the bid money. In case the bidder, who has deposited 25% of bid money, fails to deposit the balance 75% of the bid money within the stipulated period, 25% of the bid money and security so deposited with the institute will be forfeited.
5. The bidder shall have to take the goods/items/scrap away within three days, from the issue of sale release order. Failing which, the undersigned will have the right to re-auction such goods/items/scrap at bidder risk and cost and fresh auction will be initiated after 07 days and such bidder may be debarred from further bidding process.
6. Disputes if any shall be subject to jurisdiction in the court of Amb only.
